From Chesterfield

- US-40 West to Mo-94 exit toward St. Charles
- Turn right onto Hwy-94 E (3.63 mi)
- Turn left onto Mid Rivers Mall Drive (2.91 mi)
- Turn Right onto Willott Rd. (1.34 mi)
- Turn Left onto Spencer Rd. (.63 mi)

From West/Lake St. Louis

- I-70 East
- Turn right onto Mid Rivers Mall Drive, exist #222 toward St. Peters (.23 mi.)
- Turn left onto Mexico Rd.
- Turn right onto Spencer Rd.

From East/St. Charles

- I-70 West
- Take Cave Springs exit-- #225-toward Truman Rd. (.18 mi)
- Turn left onto Cave Springs Rd. (.24 mi)
- Turn right onto Mexico Rd. (2.22 mi)
- Turn left onto Spencer Rd. (.41 mi)

At corner of Spencer Rd. and Boone Hills Rd, turn left (only way you can turn); you will see the brown Non Profit Development Center directly behind the library. Turn left on Boone Hills Drive (only way you can turn at the stoplight) and turn into the 2nd driveway on the right. Follow to parking lot around the building.

Take sidewalk to the west of the building, directly behind the library, and go through the middle door--- will be marked
Follow the signs to the Non Profit Development Center.
