## Interstate 70

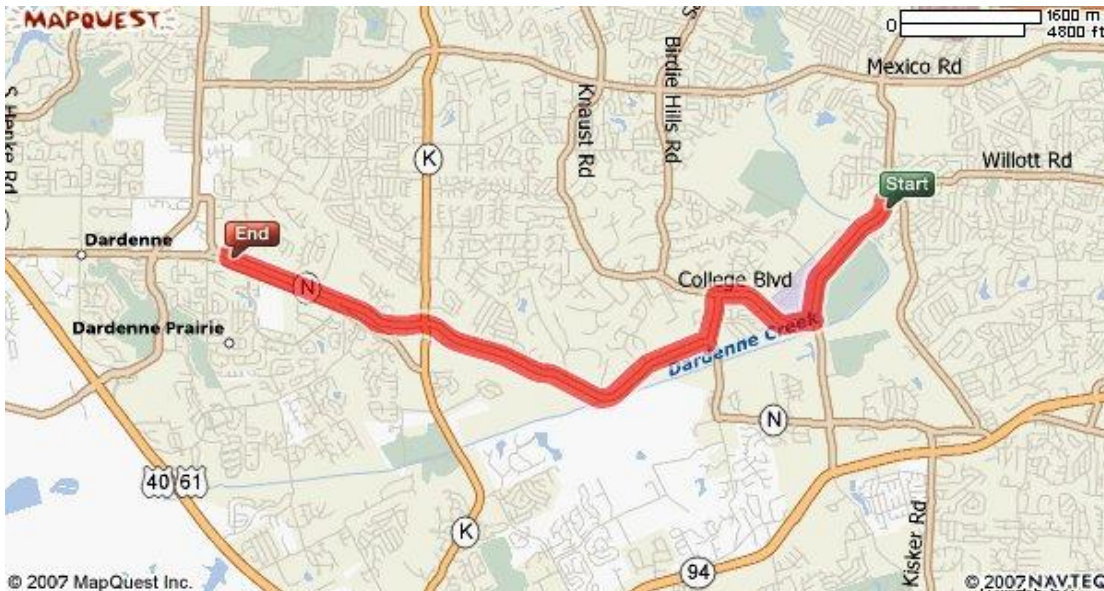
If you are closer to **Interstate 70** take 70 to **Bryan Road**. Go **south** on **Bryan Rd.** until you reach **HWY N**. Go **left** on **N** until you reach **Rondale Court** on your **left**. *Make sure your veer to the left at Bates Rd. to make sure you do not go on S. Outer Rd. 364.*

## Interstate 40

If you are closer to **Interstate 40** take 40 to **Winghaven Blvd**. Go **north** until you reach **HWY N**. Go **right** on **N**. *Make sure your veer to the left at Bates Rd. to make sure you do not go on S. Outer Rd. 364.* Continue on **N** until you reach **Rondale Court** on you **left**.
