

## People First-St. Charles County Kicks Off Annual Developmental Disabilities Awareness Month

People First-St. Charles County are once again partnering with the Developmental Disabilities Resource Board of St. Charles County (DDRB) to lead the 2013 Developmental Disabilities Awareness Month campaign in March.

Their advocacy efforts throughout the year helped them identify and develop the priority message of this year's campaign to remind all of us that words can be a taunt, a slur and an insult. Even when



well-meaning people use the word as slang, it's meaning is demeaning and exclusionary. For people with intellectual and developmental disabilities it emphasizes how they continue to be viewed as less than others while at the same time they will tell you they don't want pity; they want change.

To help reach that goal in schools, People First members are expanding their outreach efforts to include Lindenwood University students who are pursuing degrees in education to emphasize the importance of People First Language in their live s as well as in their future careers.

Another priority area People First members identified is the recent local attention to residency restrictions of individuals with developmental disabilities and the action by some cities that have revised their local ordinances to remove those restrictions. People First members will present to the council members where they reside to express their appreciation to those cities where recent changes have been made and to impress upon all council members that they are active contributing citizens who have similar goals and desires as that of their neighbors and community as a whole.
