## About the DDRB

The DDRB is a public taxing entity, commonly known as a "Senate Bill 40 Board" that enters into funding contracts with agencies that serve individuals with developmental disabilities in St. Charles County.

This public tax was established in 1977 when voters of St. Charles County approved to tax themselves up to sixteen cents per \$100.00 of assessed property valuation to provide community based programs and supports for citizens with developmental disabilities. The DDRB is a 9 member volunteer board. The administrative staff report directly to the Board, providing accountability the St. Charles County community.

## DDRB Community Programs:

- The DDRB funds several community programs supporting individuals with developmental disabilities. Each program has specific criteria which can be found on the DDRB website. Following is a listing of the current programs.

# DDRB Case Management Program implementation

In an effort to enhance the case management service delivery system, a partnership was established between the DDRB and Department of Mental Health (Division of Developmental Disabilities). The intent of this collaboration was to reduce caseloads for the local Department of Mental Health (Division of Developmental Disabilities) case managers in order to allow all case managers the ability to provide quality, individualized services to those receiving case management in St. Charles County. As a result, in May of 2006, the DDRB began providing case management to individuals 18 years-of-age and older. The DDRB now provides case management services to over 1200 customers 17 years-of-age and older. Now anyone over the age of 17 entering the case management system in St. Charles County has a choice of case management provider!

## Objectives of today's session:

#### STEP 1

Apply for Case Management Services (Also called Support Coordination)

Case Management is the link to needed resources and information. To access adult services, the transitioning student must have an open case with the Missouri Department of Mental Health - Division of Developmental Disabilities.

#### Applying for DD Case Management Services

- 1. First point of contact: St. Louis Regional Office Call 314-587-4800 Ask for "Intake and Assessment"
- 2. An intake worker will gather information and send an application packet. An appointment will be scheduled to complete an assessment to determine eligibility for services.
- 3. If determined to be eligible for Case Management services, needs will be identified and an Individual Support Plan (ISP) will be written to address those needs.



## Eligibility

A developmental disability is a disability which is attributable to mental retardation, cerebral palsy, epilepsy, head injury, autism, or a learning disability related to a brain dysfunction, or any other mental or physical or mental impairment which occurs before age 22. It must be determined that this disability is likely to continue indefinitely and that it results in a substantial functional limitation in two or more of the following six areas of major life activities: self care, receptive and expressive language development and use, learning, selfdirection, capacity for independent living or economic self sufficiency and mobility.

## STEP 2 Apply for Medicaid (MO HealthNet)

Transitioning students should apply for Medicaid when they turn 18. A child can apply at a younger age if your family meets the income guidelines. If your child is younger than 18, your total household income and resources are a factor. If your child is 18 or older, only their income and resources are considered.

Medicaid is required to access most adult services for people with disabilities.
Without Medicaid, service options are limited.



#### To apply for Medicaid:

- 1. Visit the Family Support Division office at closest to you. Search locations at dss.mo.gov
- 2. Print an application available at ttp://www.dss.mo.gov/fsd/massist.htm The link to the MO HealthNet application will be on the menu on the right of the page.
- 3. Keep copies of your application form. They sometimes get lost.
- 4. Hand-deliver or mail your application to the local office.

### **Eligibility**

- Social Security Number
- Live in Missouri
- US Citizen or Eligible Qualified Non-Citizen
- Elderly (65 and over), Blind or Permanently and Totally Disabled
- Available resources for elderly and disabled: Individual less than \$2000,
   Couple \$4000 or less
- Exclude medical savings accounts and independent living accounts for the participant up to \$5,000.00/year each and earnings on such deposits.
- Real and Personal Property for blind: Individual -\$2000 or less,
   Couple \$4000 or less
- Net Income limit for Elderly and Disabled, 85% of the federal poverty level: Individual \$855, Couple \$1,151
- Net Income limit for Blind,100% of the federal poverty level: Individual \$1,005, Couple \$1,354

## ABLE Account



One of the primary reasons that the federal ABLE Act was passed was to protect Individuals with disabilities from losing certain benefits such as SSI or Medicaid.

ABLE Accounts can be opened with as little as \$50.00.

#### **Allowable Expenses**

- Clothing
- Transportation expenses
- Services or costs not covered by Medicaid (co-pays, chore services, hours exceeding caps, dental services for adults)
- · Telephone or cable television
- Furniture or household items
- Cleaning supplies
- · Modifications to home for accessibility
- Communication or assistive devices not covered by Medicaid
- Caregiver agencies
- · Beneficiary travel expenses to visit family or for pre-approved vacations
- Pre-paid burial plan

#### **HOW ARE SERVICES FUNDED?**

#### Home & Community Based Waivers

The Missouri Department of Mental Health's Division of Developmental Disabilities (Division of DD) administers five Medicaid Home and Community Based (HCB) Waiver programs for individuals with intellectual or other developmental disabilities.

The five waivers are the Comprehensive Waiver, Missouri Children with Developmental Disabilities Waiver (MOCDD or Sarah Jian Lopez Waiver); Community Support Waiver, Partnership for Hope, and Autism Waiver.



Adult services are usually funded by the Partnership for Hope Waiver, Community Support Waiver or Comprehensive Waiver.

#### Who Qualifies for a Division of DD Waiver?

#### Comprehensive, Support, and Partnership for Hope Waivers:

- Eligible for MO HealthNet (Missouri's Medicaid program) as determined by the Missouri Department of Social Services' Family Support Division under an eligibility category that provides for Federal Financial Participation (FFP);
- Must have needs that would require care in an intermediate care facility for developmental disabilities;
- For the Comprehensive Waiver, requires residential supports;
- For the Community Support Waiver services are limited to \$28,000 annually and the participant must not require residential services. This limit may be exceeded on a case by case basis;
- For the Partnership for Hope, waiver service needs are limited to \$12,362 annually and the participant must not require residential services. If there are special circumstances, people may be able to get more services.

#### **Eligibility**

Individuals must have active Medicaid and eligible diagnosis in order to apply for a Medicaid Waiver. The Medicaid Waiver program is a combination of federal and state funds that are used to purchase services for people with disabilities. The Case Manager will need to apply for a Medicaid Waiver for the individual. The process takes several months. It is critical that the process of applying for the Waiver begins well before the funding is needed.

#### Waiver-Eligible Diagnoses

In addition to having active Medicaid, an individual must have a waiver-eligible diagnosis.

Some examples include intellectual disability, autism spectrum disorders. epilepsy, cerebral palsy and Down syndrome or other genetic disorders.

Specific learning disabilities or mental illness are not waiver-eligible diagnoses.



#### **EMPLOYMENT TRANSITION**

Students who are employment-bound can apply for services from Vocational Rehabilitation in their final year of school.

Vocational Rehabilitation (VR) is a division of the Department of Elementary and Secondary Education (DESE) that provides vocational counseling and funding for employment evaluation, training and supports for people with disabilities. Vocational Rehabilitation also certifies a person's eligibility to work in sheltered employment.

#### To Apply for Vocational Rehabilitation Services

1. The school districts have a Vocational Rehabilitation Counselor assigned to the district. Talk to your school guidance counselor about applying for services

Eligible individuals have a physical or mental impairment that causes problems with working and need VR services to be successfully employed.



#### **ADULT DAY SERVICES**

It is suggested that transitioning students visit day programs during the summer prior to their last year of school. This will help with the decision about which program is the best fit. The Regional Office or DDRB Case Manager will help arrange visits for parents. Transition visits for the student will be coordinated by the school district during the final year of school. The frequency and duration of transition visits will vary by student and day program. There are several agencies that provide adult day services. Participation in a day program requires funding from the Department of Mental Health through the Medicaid Waiver. The individual cannot participate in a day program until funding is approved. Most programs have a waiting list.













# The Workforce Innovation & Opportunity Act (WIOA)

WIOA increases individuals with disabilities' access to high quality workforce services and prepares them for competitive integrated employment.

 Youth with disabilities will receive extensive pre-employment transition services so they can successfully obtain competitive integrated employment.

#### **BEHAVIORAL HEALTH SERVICES**

If a child is diagnosed with an emotional disorder or has a problem with substance abuse, application may be made for Behavioral Health Services at any time. Crider Center is the area agency and can provide your child and family with needed support to manage mental health concerns.

#### **Eligibility**

People with a serious mental illness; Individuals and families in crisis; People who are homeless and mentally ill; Individuals committed for treatment by the court system; and Children with severe emotional problems.

#### **ADDITIONAL BENEFITS**

#### SSI (SUPPLEMENTAL SECURITY INCOME)

Transitioning students should apply for SSI at the age of 18. This should be done at the same time as the application for Medicaid. Medicaid and SSI use the same disability determination process and they share information. It streamlines the application process. SSI provides monthly income for the individual that can be used for general living expenses and other things they may need. A parent can apply for a child under 18 if the family meets low income guidelines.



#### To apply for SSI

To apply for a child who is under age 18, complete the online Child Disability Report at www.ssa.gov.

To apply at age 18 or older, complete the online Adult Disability Report at www.ssa.gov.

In addition, schedule an appointment to file for benefits by calling 1-800-772-1213 (TTY 1-800-325-0778), 7 a.m. to 7 p.m. or visit your local Social Security office between 9 am and 3 pm.

#### Eligibility

- Children from birth up to age 18 may qualify for Supplemental Security Income (SSI) benefits. They must meet Social Security's definition of disability for children and the parents and child must have low income and few resources.
- Children age 18 and over who have a disability that began before age 22 may qualify for Social Security disability benefits from a parent's record. They must meet Social Security's definition of disability for an adult and have a parent who is receiving benefits or is deceased and worked long enough to become insured.
- Under both programs, the child must not be doing any substantial work.
